GET READY FOR BOEING AVIATION IN SEATTLE

The Pacific Northwest has long been a leader in aviation for over a century. Beginning in the years immediately following the Wright Brothers first powered flight on December 17, 1903, aircraft built with wood, wire and cloth airplanes became more prevalent. Flying came to Seattle on March 10, 1910, when a visiting aviator named Charles Hamilton made the

first airplane flight in this city and a crowd of thousands came out to see him fly. Hamilton and other visiting aviators would inspire many Northwest people to become airplane enthusiasts and a few became involved with aviation including a local businessman named William E. Boeing. Boeing quickly found a passion for flying after he viewed airplanes flying during a California air show. Soon he had acquired an airplane and with a couple of flying lessons he learned how to pilot the fragile aircraft. As an advocate for flying, Boeing in 1915 flew over the University of Washington stadium to promote his vision of the airplane and flying to the public.

A year later William Boeing started a business that built the first Boeing airplane, the B&W. During the years that followed his company grew to become one of world's prominent manufacturers of airplanes. Boeing believed in innovation and he incorporated new concepts and ideas that advanced the shape and size of the airplane. Boeing airplanes quickly grew from frail, single-engine flying machines into large multi-engine commercial transports and also military bomber aircraft that flew higher / faster and carried greater payloads. In the mid-1930s Boeing advanced commercial air transportation by creating the Boeing 307 Stratoliner which first featured a pressurized passenger cabin allowing the airplane to climb to higher altitudes and fly smoothly over the weather. Boeing also developed one of the most innovative bombers of World War II, the B-17, which at peak production during the war rolled out sixteen airplanes a day from its Seattle Plant II factory.

Following the end of World War II the Company saw its aviation future with multi jet engine powered airplanes and Boeing created the B-47 and B-52 all-jet bombers for the U. S. Air Force. Additionally, began developing jet-powered commercial transport airplanes leading to the Boeing 707 and 727. The 1970s brought the world's largest and most popular airplane, the Boeing 747 and other more advanced commercial jet airplanes were to follow into the next century with the Boeing 737, 757, 767, 777 and 787.

While Boeing was always present in local aviation history over the years, other events have strengthened the regions ties to aviation with both the military and commercial airlines recognizing the Pacific Northwest as a hub for aviation. Airlines such as Northwest, Alaska and many smaller regional carriers made Seattle their base of operations. The U. S. Navy built seaplane bases at Sand Point and Whidbey Island while the U.S. Air Force and U.S. Army had military air bases at McChord Field and Fort Lewis. This region also became one of the centers of aeronautical education with its engineering school at the University of Washington.

Although there will continue to be changes within aviation, there is no question the Northwest will continue to be a significant leader in aviation for the next century. We welcome you all to our "Jet City" Seattle, Washington rich with the legacy of aviation and look forward to hosting you at the 2014 Conference.

SMU SCHOLARSHIP



IAWA is pleased to announce that Heather McKinney is the IAWA scholarship winner for 2014 from Southern Methodist University's Dedman School of Law. Katherine Staton, former IAWA President and member of IAWA's Advisory Board, presented the scholarship award at the 48th Annual SMU Air Law Symposium at the Omni Mandalay Hotel in Irving, Texas, on April 3, 2014.

Heather, from Dallas, Texas, is a graduate of the University of Illinois (Chicago). She plans to complete her law degree in May 2015. Heather is a member of the Phi Delta Phi International Legal Honor Society and is a staff editor on the SMU Law Review.

Heather became interested in passenger transportation and related liability issues when she worked for a speedboat operator as an undergraduate in Chicago. Upon moving to Dallas to attend law school, she began to work for an

IAWA-ICAO AVIATION SCHOLARSHIP

On March 26, 2014 IAWA was invited by the Galería de Aviación Latinoamericana (GALA) to accept an award to Amelia Earhart. GALA held a ceremony to celebrate the winners of the 2014 Awards, as part of the <u>IATA Conference Wings of Change</u>, held every two years in Chile within the event Feria del Aire y del Espacio, FIDAE (Air and Space Fair of Chile).

GALA was created with the purpose of honoring and recognizing aviation related men, women and entities in Latin America who have contributed to the development of the aviation industry in the region, and to highlight the importance of aviation to our lives and history.



IAWA was honored by being invited to accept the recognition of Amelia Earhart as a Pioneer in Latin American air transport. Amelia Earhart's works and deeds have stood out throughout the aviation history of the region, paving the way for today's aviation. Alina Nassar, Partner at Nassar Abogados in Costa Rica and IAWA Board Member & Vice-President for Public Relations and Communications attended the ceremony and accepted the award: "It has been an honor to represent IAWA in accepting this recognition to a woman who has inspired us all, men and women equal. With courage, determination and enthusiasm Amelia Earhart broke all conventionalisms to pursue her dream and a milestone in aviation. She has been and will be, without doubt, a source of inspiration and admiration for past, present and future generations".

5TH ANNUAL OUTSTANDING AVIATOR AWARD

On March 26, 2014 IAWA joined the Wings Club in presenting the fifth annual Outstanding Aviator award to Robert A. "Bob" Hoover, Former Air Show Pilot and US Air Force Test Pilot. The Outstanding Aviator Award is given jointly by the Wings Club and IAWA with recognition given to an airmen or airwomen on alternative years. Although Bob was not able at the age of 95 to travel to the Wings Club, there was a video presentation as well as some stories told by Bob who did call in via phone. Not only was Bob an inspiration to us when he was still flying but to listen to him - still vibrant at his advanced age had us all enthralled.

Attending the presentation and reception at the Yale Club in New York City representing IAWA were Ellyn Slow, who presented



the award with Ken Gazzola; Mary Ellen Jones, a Wings Club board member, Stephanie Hobart of Pratt and Whitney, Laurence Vigeant - Langlois of Sikorsky, Andrea Brantner of GECAS, and Sharon Devivo and Amanda Talty both from Vaughn College. A wonderful time was had by all.

Bob Hoover is considered one of the founding fathers of modern aerobatics, having thrilled millions of men, women and children over the past five decades with his acrobatic flying maneuvers. Additionally, he has flown over 300 types of aircraft and flight tested or flown nearly every kind of fighter aircraft. Referred to as "The Pilots' Pilot," Hoover was a fighter pilot during WWII. After flying 58 missions, he was shot down off the coast of southern France and spent sixteen months in a German prison camp. He managed to escape from the prison camp,



stole an FW 190 and flew to safety in the Netherlands. After the war, he was the backup pilot in the Bell X-1 program and flew chase for the Lockheed P-80 Shooting Star during the March 1 flight.

He's best known, however, for his civil air show career, which started when he was hired to demonstrate the capabilities of Aero Commander's Shrike Commander, a twin piston-engine business aircraft. Hoover has set records for transcontinental and "time to climb" speed and has personally known such great aviators as Orville Wright, Eddie Rickenbacker, Charles Lindbergh, Jimmy Doolittle, Jacqueline Cochran, Neil Armstrong and Yuri Gagarin.

IAWA INSPIRES AT UNITED AIRLINES' UIMPACT!

uIMPACT is United Airlines' newly created diversity business resource group for women, led by IAWA member Mandeep Grewal. Its name tells you about their mission: promoting movement, advancement, and connection for women at United. Mandeep chose IAWA's Advisory Board Chair Kris Fellrath to be the first speaker launching their distinguished speaker series. Three years



ago Kris truly inspired Mandeep at IAWA's conference in Paris and she immediately thought of Kris as the perfect first speaker to inspire this group of almost 300 women at United. Mandeep's team also created "Passport to Success", the group's incentive program where members who attend uIMPACT events will qualify for a drawing to win a company-paid trip to the IAWA's Conference in Seattle this October! We will be thrilled to meet the uIMPACT attendees at this year's IAWA conference and hope this program will inspire other companies to form women diversity groups within our industry.

CAREER CONNECT

INTERVIEW WITH FRANCINE KERNER

I had the privilege of meeting Francine at the IAWA breakfast held in San Francisco during the 2014 IATA Legal Symposium in February 2014.

Of course, I knew Francine by reputation and I must say that I was a bit nervous to meet such an accomplished woman.

The first thing that struck me when I met her was the sparkle in her eyes when she talks about her role at the U.S. Transportation Security Administration (TSA). Francine has been the TSA's Chief Counsel since January 2002. As part of the TSA's senior management team, she helped lead the effort to secure and successfully restore confidence in civil aviation following the September 11, 2001 attacks. She told me that she always wanted to be a lawyer and that her deepest motivation was to keep the streets safe. When she was studying law, Francine said that there were not many women in law schools at the time. She was inspired to study law by her father who was also a lawyer. When she was 5 years old she asked her father why she did not have a middle name like her younger brother. He told her that her brother's middle name was given in anticipation of him becoming a professional later in life. But she then immediately replied: "But I may be a professional too!" After that exchange, her father registered her in pre-school with a middle name of her choosing. That was a turning point.

Here are the pieces of advice I retained from this enriching meeting with Francine:

 Be passionate about what you are doing
 Being committed to whatever it is that you are working on is key to achieve your goals. When we are passionate about our work, we have more energy, more creativity, can work

Francine Kerner assumed the position of Chief Counsel at the Transportation Security Administration in January 2002. She advises senior officials on all legal matters relating to protection of the nation's

transportation systems.

As TSA's first Chief Counsel, she was responsible for providing legal advice and services in connection with the largest mobilization of a civilian government agency since World War II. This mobilization resulted in the hiring, training, equipping and deploying of more than 60,000 employees to more than 450 locations in less than a year and the execution of a three year budget in excess of \$16 billion.

As part of TSA's senior management team, she helped lead the effort to secure and successfully restore confidence in civil aviation following the September 11, 2001, attacks, working with senior Bush Administration officials, Congress and stakeholders to enhance security in all modes of transportation. As Chief Counsel, Kerner has built a nationwide legal office, hiring attorneys and support personnel from over 56 government agencies, private firms and corporations.

Before joining TSA, Kerner held a variety of senior legal positions at the departments of Commerce and Treasury. In her previous position as Deputy Assistant General Counsel for enforcement at Treasury, she provided counsel on a wide range of sensitive and complex matters involving Treasury law enforcement agencies.

Before joining the federal government in 1979, Kerner served a:s an Assistant District Attorney in the Kings County District Attorney's Office in Brooklyn, N.Y.

In 2001, she received the Presidential Meritorious Executive Rank Award for outstanding contributions as a federal attorney. In 2013, she received the Burton Award for legal achievement in public service, and was also named by the District of Columbia Bar as the recipient of the Beatrice Rosenberg Award for Excellence in Government Service. She is a graduate of Queens College in New York City and New York University School of Law.

harder and inspire others. It also helps to have clarity on why we are doing what we are doing. But she cautioned that we must not ignore our loved ones in pursuing work goals; we need to make certain that we are diligent about other things in life that matter just as much, such as family.



2) Always stay intellectually honest

To be rigorous, not biased and act ethically. To follow our own conscience with respect to the arguments we make or the positions we advance means that we must be willing to acknowledge publicly when we are wrong or that valuable alternative points of view exist. This honesty as a professional makes us trustworthy to our colleagues.

3) Have clear professional objectives

Developing clear professional objectives forces us to think about what we want, the jobs we wish to perform, and skills we need to develop. Having such objectives help us identify our destination and create the roadmap for getting there.

4) Be your own advocate for success

We have to be our own advocate in order to reach our professional objectives. We must know our strengths and weaknesses, and create our own opportunities rather than merely waiting for others to show us the way forward.

Hillary Clinton was in Montreal recently and I attended her conference and one of her key messages seems to move into the same direction: women need to take more risks, not hold themselves back, and must dare to compete.

When I see Francine's accomplished life, knowing that she is surrounded by her loved ones and in possession of a job she is passionate about, I start thinking twice about the adage that "women can't have it all". Being a woman gives us a special role in the world and with determination I think we can succeed in all roles of life. Francine is a truly inspiring role model and a woman I admire.

A success for one woman in any industry is a success for all women in the workplace. Thank you Francine!

WE SERVED TOO, THE WASP STORY

In the days following December 7, 1941, one question burned in the minds of all American citizens, "What can I do to help." Patriotism was at an all-time high. Flora Belle Reese was just 19 years old when she volunteered her services. "Everyone wanted to join the service. We were anxious to do something for our country – everyone wanted to do their part and support the war effort."

Reese would become one of 1820 women who were accepted in a program called, the Women Airforce Service Pilots (WASP) during World War II. The WASPs were the first women to ever fly for the U.S. Military. They flew over 60

million miles of domestic wartime duty within a two-year period, delivering over 12,000 aircraft and piloting every plane in the U.S. arsenal.

However, after a nasty and aggressive campaign by male pilots who wanted the WASPs jobs, they were the only wartime unit that was denied military status by Congress and sent home before the war was over and their job was done. They received no military benefits or insurance and if a WASP died during their service, they were not allowed a military burial.

After their disbandment, the WASP records were sealed and classified for over 35 years. During this time, the WASPs were not allowed to pilot a commercial or military airplane. Then in 1976, the Air Force made an announcement that said, "For the first time is U.S. history, women will be flying military airplanes," essentially forgetting what the WASPs did some 30 years before. After the announcement, many of the WASPs decided to band together and storm Washington to fight for veteran's status.

Then in 2010, the remaining WASP and their supporters lobbied congress to award the Women Airforce Service Pilots with the Congressional Gold Medal; hoping they would finally receive the recognition they had been denied for so long. A new documentary called "We Served Too", provides a first hand account from WASPs who share their stories and discuss their unique experiences during the three pivotal periods that make up the WASP history. WASP historians, authors, and family members also share their stories and knowledge. The film has been airing on PBS nationwide and has won a Gracie Award for Best Documentary.

The WASP story is a forgotten one. It is not taught in our schools, nor is it written in our history books.

U.S. SUPREME COURT RULES THAT THE AIRLINE DEREGULATION ACT PREEMPTS COMMON LAW CLAIMS

On April 2, 2014, the U.S. Supreme Court issued a ruling which clarified the nature of claims that are preempted by the Airline Deregulation Act ("ADA"). In Northwest v. Ginsberg, a unanimous Supreme Court held that a plaintiff's claims arising from an air carrier's revoking of a passenger's membership in the carrier's frequent flyer program were preempted by the ADA, which prohibits states from enacting or enforcing a law, regulation or other provision that relates to a "price, route or service of an air carrier." The decision is important because it reinforces the preemptive reach of the ADA with respect to claims arising from state-imposed obligations that affect an airline's rates, routes and services. Brent crude hit a nine-month high of \$115 a barrel on Thursday and has risen more than 5 per cent since militants entered the Iraqi towns of Mosul and Tikrit on June 10. Although jet fuel prices have not risen as much, airline shares have responded by falling sharply. European airline shares are down 13 percent in the same period, according to MSCI, the index provider.

Fuel costs account for a high proportion of European airlines' costs. Although the region's airlines typically hedge their costs more aggressively than their Asian and US counterparts – with some having hedged as much as 70 per cent of their 2014 fuel needs – several will be caught out by the oil price rise.
