Greetings fellow IAWA members,

Here in the United States we recently celebrated the Memorial Day weekend, our official start of the summer season. As we entered into that holiday weekend, the price of oil soared above \$130 per barrel. I recall at our conference in Buenos Aires last November how bewildered we were that oil was certain to exceed \$100 per barrel. And we continue to ponder, as we did then: Where will this end? How will this end? And what will it do to our industry?

In 1988, crude oil was roughly \$35 per barrel. An Aloha Airlines 737 operating to Maui lost much of the top of the aircraft, launching industry concerns over how to preserve aging aircraft. Airbus introduced the A-320 to meet the new niche for smaller jets to serve as feeders on the hub and spoke system. The United States had two major commercial aircraft manufacturers, McDonnell Douglas and Boeing. And a group of women involved in one way or another with all of these issues met in Chicago and formed this organization. At our annual conference in October, a panel of these founding members will share their thoughts on how the industry has changed, or not, over these past twenty years.

Twenty years. Two decades. It sounds like a long time but in many ways, it seems like only yesterday. Where were you twenty years ago? I was in my second year of law school having put aside my ambition to become a commercial airline pilot in exchange for the pursuit of a legal career. I did not know then that looming on my horizon was an opportunity to do both. Shortly after graduating from law school, however, I got a call from the Assistant Director of the Aviation/Admiralty Section of the Torts Branch at the Department of Justice inviting me to come in for an interview. The rest, as they say, is history. I have been at Justice ever since where I have enjoyed being able to pursue my love of aviation while practicing my trade as a litigator.

Over the years I have had the opportunity to work on many exciting cases and issues. I have been allowed to work independently and always encouraged to stretch; to be better, as a person and as a professional. All of which has led to a very satisfying career. That Assistant Director who called and invited me to interview, by the way, was **Kathlynn Fadely**, one of the founding members of IAWA. Kathlynn is still the Assistant Director in my office. She has, for the last 18 years, been my boss, my mentor and my friend. When I began my career at Justice, Kathlynn took me under her wing, as I have seen her do with many young lawyers. She often patiently showed me the ropes, but also let me find my way. I have also had the good fortune to have the continual support and encouragement of Kathlynn and my Directors in my involvement in outside organizations. Indeed, when I became Senior Aviation Counsel, Kathlynn enthusiastically encouraged me to join IAWA.

My career at Justice and my development as a professional has been greatly enhanced by mentors, such as Kathlynn, that I have had at Justice and in my professional associations. I know that many of you have had similar experiences on the road to your successes. Our careers, indeed our lives, are significantly enhanced by having good mentors.

Because we recognize the value in having mentors, the IAWA Board is exploring the (continued)
