# 23rd Annual Conference Highlights



## 23rd Annual Conference News

### 23<sup>rd</sup> Annual IAWA conference in Paris: A resounding success!

On Thursday the 17th of November 2011, IAWA held its 23rd annual conference in Paris. With 218 attendees the conference proved to be one of the largest ever. Kat Staton, the outgoing President, opened the conference by extending her thanks to all the sponsors and supports of IAWA. Without their dedication IAWA would not be able to touch such a

wide audience around the world.

The first panel addressed the question of "Why don't more women run Airlines?" Quince Chong of Cathay Pacific opened the panel. While they have a gender-neutral employment policy, Quince is the only woman on the main board structure. She started with some inspirational stories about her team and how they collaborate. There continue to be barriers to break down in order for more women to run airlines. Siza Mzimela. Group CEO South African Airlines. told the audience that the glass ceiling is only as high as the "guys have made it." She impressed upon the audience that women can't try to be like men - we need to use our own skill set. Christine Ourmieres of City Jet, the biggest carrier in London City Airport told the audience that 13 of 200 CEOs of commercial airlines are female. Contrary to popular thought the US is not a leader in this way - Africa leads the way. Mentoring was a large theme and a lively debate ensued with audience participation. Next up was the Insurance panel moderated by Patti Moores of AON. The panelists included

Vonnick le Guillou of Bird and Bird and Sophie Marx of the Paris based broker, OAAGC. Sophie discussed war and terrorism exclusions and how to "buy back" these coverages. Sophie touched upon the need for a risk to be in existence. The

panel discussed how it seems strange that threats against countries have to be transferred to the insurance balance sheets. Embargo and sanctions were also discussed.

The following panel had lively discussion regarding "Airports and Air Traffic Management: Strategies, Technology and Human Resources, New Challenges" with Eugenia Llorens Beltran de Heredia, SESA, Dottie Hall GE Aviation and Shaunta Hyde, of The Boeing Company. Geraldine Naja of the European Space Agency explained that her agency's goal was to engender research and technology and their application in space. Programs include human spaceflight, Earth Observation and Robotic Exploration. EASA's ongoing project is to launch a mission to drill the soil of Mars to two meters in search for biological life. Another is the mapping of sea ice and its effect by global warming. She added that space is an important part of our daily life - but it is threatened by pollution. EASA is working on addressing this pressing issue. Claude Dubreuil of Atrium spoke of technology that enables space exploration and planetary missions. The International Space Station is a key facet of their mission statement.

The Aircraft leasing panel discussed the fact that financing of aircraft is changing due to the banking situation. There are also regulatory changes to be managed in the commercial finance sector. The next panel discussed the issue of Aviation and Climate change and what this big issue held for future developments in the industry. The panel led by Nancy Young, included Linda Koppel of Ethihad Airways and Angela Foster-Rice of United Airlines.

The evening brought a special event hosted by Boeing in the opulent Salon Opera in the Hotel Intercontinental Paris le Grand. The evening's proceedings were opened by Jean-Pierre Raffarin, Vice President of the Senate and previous Prime Minister. The conference was later treated to a speech by Sally Bondy of Boeing Aircraft Company.

The program on Friday was equally hard Hitting. The conference resumed with a membership meeting followed by the introduction of our 2011 scholarship recipients.

The first panel addressed the age old conundrum – "Breaking the Glass Ceiling" conducted by the IAWA Advisory Board. Kris Fellrath of Boeing engaged the audience in a discussion about how we advance ourselves.

Impressively, Kris has responsibility for 3,000 people. Kris has strong thoughts on how to advance in business. She asked the audience to reflect on the following:

1) Do you know yourself?

2)What is your legacy?.3) Are you doing enough?

Rene Martin Nagle told us "she broke the silence – the glass ceiling and an occasional glass." As the only senior woman at the beginning of her career she was lonely so she started mentoring. Rene advised the audience "Always tell the truth and face the difficult issues including the elephant in the room."

Elizabeth Freidenburg simply told the attendees to work hard. She beseeched them to realize that it is not that difficult - you can do it. One piece of personal know-how she shared is that she always responded to clients immediately. Even though she may not necessarily have had the answer there and then she would always say "I am working on it!" Suzon Franzke relayed some amazing and entertaining stories about her fellow panellists. Her mantra contained many pearls of wisdom. She implored the audience to always move an initiative. If it is bold and you have done your homework – proceed. Suzon offered that we must balance as best we can. "When you feel overwhelmed - stressed beyond comprehension – when obstacles seem insurmountable - remember that you hold the key to your success. You are the CEO and you are president of yourself. Give the stock to who you choose. You are the key to your success!"

Elisabeth Ourliac at Airbus, discussed the birth of Airbus. Constituent countries splintered corporate structures and different cultural understandings were an obstacle in the beginning. Elisabeth's recipe for success includes starting from a common goal. In the case of Airbus, this was a product and customer focus goal.

Gala Goncalves of EADS began by expressing her gratitude to the first panel for their touching insights. Gala shared the challenges that had to be faced . Jenette Ramos of The Boeing Company continued the theme with lessons from her company. Mary Ellen Jones of The Engine Alliance told the audience that while her company teams on some forums as partnerships there is massive



competition in most arenas. The panel discussed the supply chain question.

Panelists are worried about the industry's ability to meet the many obligations. The next panel focused on Benefits and

Boundaries of Airline Alliances – Patricia Delgadillo shared the view that alliances help airlines meet customer expectations, especially in times of delay in different parts of the world.

Cynthia Joy of Air Canada discussed Star Alliance. Focus on client service has seen great improvements in international travel connectivity.

The panel discussed "Metal Neutrality". A++ Joint Venture. This is the idea that the customer doesn't have to fly on your airline's "metal" – any of the partners are parallel. Barbara Van Koppen of KLM Royal Dutch Airlines, commented that more joint ventures are being created within alliances and this leads to a lot of scrutiny by EU and regulatory bodies. A resounding success, the 23rd Annual IAWA conference came to an end following a thought provoking luncheon speech by Aude de Thuin, President of the French Forum.

The board of IAWA looks forward to seeing you all at the 24th Annual conference to be held in Dallas, Texas, October 3-5 at the Adolphus Hotel!

## IAWA Website

### Navigating the IAWA website

One of the objectives behind the IAWA website relaunch was to bring some consistency to the website. And the biggest part of that was to put most information in public areas that didn't require logging in. What that means is that to view event photos, read News & Views newsletters, and even renew memberships; there is no need to dig up an old User ID and Password.

Further simplification included placing the three most popular menu links (Calendar, Newsletters and Photos) in the top menu bar (Fig. 1). One click and the calendar *(or photo album or News & Views)* unfolds!

#### So why have a login window on the website's left-hand side?

The answer is that behind that login window is membership directory – Names, phone numbers and addresses so members can interact with each other. After an IAWA member logs in, the top menu bar changes (Fig. 2). Two new options appear – Clicking on "Members" takes you to the membership directory and "Log Out" is useful if you're at a public computer.


