Scholarship Program Expands To McGill University in Canada

AWA's Scholarship Program has expanded to McGill University of Montreal Canada. The program has been endorsed by Prof. Dr. Paul Stephen Dempsey, the school's Tomlinson Professor of Law and Director of the Institute of Air & Space Law at the school.

With the addition of McGill, the program is operating at Embry-Riddle Aeronautical University of Daytona Beach, Florida, and Southern Methodist University of Dallas Texas.

Students at McGill were notified of the scholarship opportunity in an e-mail from Prof. Dempsey that included the scholarship application form.

The scholarship program was started by IAWA to support the professional development of women. Scholarships are awarded to women students majoring in Aviation Law, Management, Business or Finance. Each year the IAWA Board works with designated schools to identify candidates for a scholarship. McGill now is one of those schools.

Since 2004, IAWA has awarded scholarships to five students, three from the United States and one from Ghana who were attending Embry-Riddle, and a young woman from Hong Kong, a student from Southern Methodist University.

When ICAO first came into being on 4 April 1947, following the signing of the Chicago Convention on 7 December 1944, most of the professional staff of ICAO were men. This fact reflected the aviation industry in general during that era.

Over the years and, in particular, in recent times, efforts have been made to try to increase the number of professional women throughout the Organization. This is also in line with the directives of the United Nations, that there be equal representation of women and men.

An Affirmative Action Plan for the recruitment and status of women is under way at ICAO and we are particularly striving to recruit qualified women for senior positions. These include posts of Director and Deputy Director of Bureaux at Headquarters, Regional Director and Deputy Regional Director in the Regional Offices.

Positions at ICAO require staff with a variety of different backgrounds. These include not only administrative positions, but there are also opportunities for those with experience in law, aviation security, economics and statistics, air traffic management, accident investigation and prevention, operations/airworthiness, flight safety the transportation of dangerous goods, the environment, and many other disciplines.

While applications from all qualified candidates are welcome, those from suitable female applicants are especially encouraged.
