

# IWPC 2020 Rescheduled for April 19-21, 2021

Based on public health recommendations to limit large gatherings, we have decided to cancel IWPC 2020. This was a difficult decision, but we believe it is the best way to protect the health and safety of our attendees, speakers, and exhibitors. Given the speculative nature of when this crisis may be over, and the domino effect on everyone's schedules, IWPC 2020 will not be rescheduled. Next year's IWPC 2021 (**April 19-21, 2021**) was already on the books with planning set to start in August 2020 a mere four months away.

IWPC 2020 was on track to be Illinois' best water resource and recovery conference and we will do everything we can to provide the same valuable conference next year! We want to thank all our exhibitors and attendees for their continued patience and support as we work through transitioning to the 2021 conference.

We will provide more information as it becomes available but initial answers can be found below. As arrangements are still a work in progress, we expect quite a few inquiries. Your patience is appreciated as we try to respond as quickly as possible. Please understand that it may take some time to solidify the necessary details so we can respond with the most up-to-date information.

## Attendee Registration:

If you have already registered for the IWPC 2020 conference, your registration will be automatically transferred to IWPC 2021 - there will be no need to reregister. Registration confirmations will be sent to all registered attendees in December when registration for the 2021 conference opens.

Attendee substitutions will be available and can be made starting in December as well. Attendee registrations held over from IWPC 2020 will be exempt from any price increases for IWPC 2021. Of course, the 2020 registrations will remain fully refundable and changeable prior to IWPC 2021.
